6. TRAVEL TRAINING PROVIDER UPDATE – ACTION FROM JULY MEETING ADAM BISHOP

The new travel training program began in January 2024, through CBI Health and is in the rebuilding phase. The program is currently doing three to five intakes per week and is working with BC Transit's Safety and Training team when a bus is required for 1:1 training support.

Anyone can call BC Transit and request help with learning the conventional transit system or to see if they qualify for the handyDART system (or both).

The process is:

- Intake through CBI
- One to three sessions with a travel trainer to learn routes
- Follow-up from the consultant to see how the rider is making out on their own using the system

Group training is also available which can be used at seniors facilities etc., and training is not limited to those who use mobility aids.

FOR ACTION: Suzan Jennings has volunteered to try the new travel training system with CBI and will report back to the committee at a future meeting.

8. handyDART FACILTY UPDATE

In late March or early April there will be tours and grand opening/open house scheduled for the new facility. The building will be Rick Hansen Certified for accessibility needs and is aiming to be LEED Gold certified. This project has also involved a successful stream revitalization program.

Front reception and training facility will be equipped with hearing loops and braille on the signage, as will the Provincial Distribution Centre.

There is a newsletter that gives updates on the facility.

M. Kang has invited Heather Stewart, Executive Director, Passenger Transportation Board (PTB) to speak with the committee at a future meeting regarding Taxi Saver being open to all taxi companies. Yellow Cab previously pulled out of agreements with BC Transit for both the Taxi Saver and Taxi Supplement program. There was a bill of rights outside of Metro Vancouver stating that no one could be denied access to transportation due to a disability.

Billing times were the initial issue. The payment times have been decreased to within one month; however, Yellow Cab has been unwilling to revisit the agreement.

A new subcommittee will be created to brainstorm ways to entice Yellow Cab to return to the Taxi Saver program, and to research partnering with social programs to provide taxi savers to persons requiring transportation to medical appointments etc.
