Ms. Stewart presented on behalf of the Passenger Transportation Board (PTB).

Points of discussion from the presentation were:

- Confirmation that the Taxi Bill of Rights program is voluntary and Yellow Cab will not be returning
- There are Wheelchair Accessible Vehicles (WAVs) approved by the PTB that are not being utilized by the local taxi companies
- If poor service, or long waits times, are an issue, individuals may lodge a formal complaint through the PTB and it will be added to the providers file.

**8. RIDERSHIP CONCERNS – DISCUSSION**

Recently, the new handyDART facility opened. ATAC members were pleased to be at the Grand Opening as they saw it as new opportunities with more buses, drivers and service. Unfortunately, services appear to have dropped off rather than increase. The media has been reporting on the perceived drop-in service and ATAC members would like to know why there are so many issues booking trips or even getting through to the office.

Transdev is working to correct the issues that have come up recently by reviewing process. They have tightened up parameters

BC Transit representative, Chelsea Mossey, explained that accrued hours from earlier in the year were used at the end of the year giving the perception of more service. Once those accrued hours were used up, the service went back to the regularly budgeted hours which made it seem as though the service had been cut.

The other misconception is that when the new handyDART facility opened there would be an immediate increase in the number of buses and service. However, that is not the case. It gives the ability to expand the fleet and service, but expansion is not expected until next year (fiscal 2026/27).
