## 7. VICTORIA REGIONAL TRANSIT PLAN (VRTP) UPDATE – FOR INFORMATION ELISE WREN AND ADAM BISHOP

At the September 2025 meeting, Levi Meginbir, Manager, Service Planning, presented the new VRTP which outlines the plans for transit growth and infrastructure for the next 25 years.

A survey to collect public input will be online until October 26, and BC Transit is hoping as many people as possible will take part to give their feedback on conventional service in the Victoria area. Open houses and engagement sessions have been happening with major stakeholders (School Districts, hospitals, Canadian Armed Forces, neighborhood associations) to get their input on the growth of transit in the region over the next 25 years. BC Transit teams have also been holding information sessions for the public, the next are scheduled at Uptown on October 22 and October 25.

Levi will join the committee at the December meeting to see if members have any more input.

Adam Bishop will share a link to another survey that will pertain to handyDART services, and requests that ATAC members please share with the groups and agencies they are involved with. The responses collected will help shape handyDART service in the future.
